Application: For grouting applications, product should be poured immediately after mixing from one side, in order to allow the air displaced by the mortar to escape. To acquire an easily placed mortar, the product should be continuously poured from a 150 -200 mm height. EPOGROUT/st is formulated for 20 - 40 mm thick layers per application.

· Chemical Resistance:

After the product fully cures, **INKA EPOGROUT/st** is resistant to all inorganic agents like diluted and concentrated acids, alkalis, detergents, disinfectants, mineral oils, animal fats, salt water and • R11 Highly flammable. solvents like diesel, gasoline, alcohol etc. except oxide containing chemicals. It is not resistant to phenol, phormic acid, acetic acid and high level acid containing environments.

# ATTENTION

- · For cases where the minimum waiting time inbetween layers is to be exceeded, sanding should be made on the first layer in order to ensure adhesion between layers.
- Ideal working temperature is 20°C. Application should not be made where ambient temperature is below +8°C and relative humidity is above 70%.
- Surface temperature must be 3°C higher than the dew point.
- The product should be protected from chemical and physical impacts during the 7 day curing process.
- · Adequate ventilation should be provided for closed spaces.
- · Special thinner can be used for cleaning.

# Surface Preparation

Concrete surfaces: Concrete must be cured for at least 28 days. It should be dry, free from loosly adhering particles, laitance and grease. All particles must be vacuumed from the surface before application. Sand blasting must also be made if needed.

Steel surfaces should be free from all loose particles like rust, dirt, grease etc, and should be sand blasted up to the Sa 2,5 standards. The surface should be primed within the 4 hours of sanding process.

Product Preparation: The resin Comp.A is mixed with a slow speed mixer while adding the hardener Comp.B (@ 200 - 250 rpm)(In order to prevent excessive air entrainment into the product, the mix should be made slowly!) Excessive amounts should not be prepared considering the pot life of the product.
